Thank you for choosing Salt Spray Sheds, Inc. for your custom door design. We take pride in providing high-quality products that meet the needs and expectations of our valued customers. To ensure your satisfaction and confidence in our doors, we offer the following limited warranty:

Warranty Coverage:

Salt Spray Sheds, Inc. guarantees its custom-built shed doors to be free of material or manufacturing defects for a period of 2 years from the date of purchase. This warranty is granted to the original purchaser of the door and applies to the original building where the door was installed. Please note that this limited lifetime warranty is not transferable. Please note that the doors provided may require regular maintenance, including the application of multiple coats of paint. It is imperative to understand that a single coat of paint applied only once is insufficient to maintain the integrity and longevity of the doors.

To ensure optimal performance and durability, it is strongly advised to follow the recommended maintenance guidelines. This includes applying multiple coats of paint as per the provided instructions. Failure to adhere to the recommended maintenance procedures may impact the performance and lifespan of the doors, and may void any applicable warranties.

It is the responsibility of the purchaser to properly maintain the doors in accordance with the guidelines provided by Salt Spray Sheds, Inc. We recommend consulting a professional painter or following industry best practices to ensure that the doors receive adequate protection and meet the necessary standards.

Salt Spray Sheds, Inc. shall not be held liable for any issues arising from inadequate maintenance, including damages resulting from a failure to apply multiple coats of paint. This includes any associated costs, repairs, or replacements that may be required due to neglect or improper maintenance.

By purchasing and accepting these doors, the customer acknowledges and agrees to the importance of proper maintenance, including the application of multiple coats of paint. It is the customer's responsibility to ensure compliance with these guidelines and to maintain the validity of any warranties provided.

Warranty Exclusions and Limitations:

The following are exclusions to our warranty coverage:

- a) Neglect, alterations, natural disasters, wind damage, accidents, or misuse.
- b) Unprimed or unpainted doors, including all 6 edges of the door, with dark colors. Doors coated only with primer or sealant are not covered.
- c) Improper use or abuse of the door, including excessive wind gusts and improper shutting.
- d) Exposure to acid, corrosive chemicals, extreme moisture, or continuous contact with ground or decking surfaces.
- e) Failure to adhere to suggested maintenance procedures.

- f) Natural disasters or unforeseen catastrophes such as fire, flood, water, wind, earthquakes, etc.
- g) Unauthorized changes to the original structure of the door.
- h) Any work performed on the door by a contractor other than Salt Spray Sheds, Inc.

Warranty Claims:

If you believe your door is experiencing a defect covered by this warranty, please file a claim with the following information:

- Nature of the defect
- Proof of sale within the last 24 months
- Name and address of installer and owner
- Door description

Warranty Responsibility:

Salt Spray Sheds, Inc. will only be responsible for material defects covered by this warranty. We will cover the original purchase price of the door, or any costs associated with repairing the door, performed by Salt Spray Sheds, Inc. We are not responsible for costs related to a replacement door, labor, or finishing that is out of warranty or voided by warranty.

Limitation of Implied Warranties:

This warranty is not valid in states that do not allow the limitation of implied warranties or the exclusion or limitation of consequential damages. No other implied or expressed warranties are recognized, except to the extent allowed by law.
